5. Planning Applications and appeals

To review and confirm the responses made to Wycombe District Council by the planning committee. (Updated list sent prior to meeting)

- Planning Reference 15/06133/FUL these are amended plans and we will restate our objections.
- The Bernard Arms -The Clerk has, once again, been in contact with WDC about the derelict and dangerous state of the building. WDC have tried to make contact with the Owner and Agent to get the building made safe and served notice to them to do so. However, the notice was ignored so WDC have boarded up the building. WDC are unable to do anything about the fly tipping in the car park as it is on private land.
- The parish council have been contacted regarding an alleged breach of planning at Brook Farm, Marsh, the Clerk will ask WDC to look into this.

6. To approve Annual Return 2015/16

The Clerk reported that the internal auditor had inspected the accounts and signed the section of the Annual Return relating to internal audit. He had made one suggestion of a different way of keeping the budget spreadsheet which the Clerk will introduce.

There being no questions or comments, the Annual Return was agreed and signed by the Chairman and Clerk. The Clerk stated that the Annual Return would now be submitted to the External Auditors.

7. Local Priorities Funding Award - Church Lane - Update

Ellesborough Parish Council have agreed to contribute up to £822 towards the cost of the feasibility studies, should they be deemed necessary after the results of the Transport Assessment are known.

8. Playground Refurbishment - Update - Cllr Delia Burton

Phase 2 is due to start on 13th June 2016, Councillor Burton will oversee.

The Clerk will contact WDC to establish if the annual RoSPA inspection has taken place and, if not, ask them to delay until after phase 2 is complete.

The Clerk will investigate the possibility of erecting a sign regarding stating no overnight parking in front of the war memorial. Exact wording to be agreed.

Summary

An E Petition was posted on the County Council's website on the 20th May regarding house vibrations and speeding on the A4010.

The petitioners are requesting the council:

"investigate the state of the road and what is underneath the road that is causing the whole house to shake with vibrations when buses and trucks go past at a speed which is which is way over the 40mph speed limit. Also please lower the speed limit."

The County Council is aware of the concerns of residents in this area and has had regular correspondence over the matter. A vibration report in 2014 for one of the properties on Old Chapel Close concluded that vibrations levels "have been found to be significantly below the levels at which cosmetic damage could possibly occur" although it also concluded that "vibrations are perceptible and a cause for complaint". The road is inspected on a monthly basis and repairs to local defects have been, and continue to be made, to keep the road safe and to reduce nuisance to residents. Officers have also met the lead petitioner on site to discuss the matter.

The speed limit on the A4010 at Kimble was reviewed in 2006 and reduced from 60 mph to 40 mph. During a follow up review in 2009 the 40 mph speed limit was extended further north. As a result of the previous reviews and the low collision history the speed limit at Little Kimble does not meet the DfT guidance for a 30 mph speed limit and the County Council has concluded that the 40 mph speed limit on the A4010 at Little Kimble is an appropriate speed limit for this 'A' class primary route.





Recommendations

- The LAF notes the report and provides feedback on the relative priority of repairs to this road for consideration.
- Transport for Buckinghamshire (TfB) continues to inspect the road and repair defects in accordance with current policy.
- Great and Little Kimble cum Marsh Parish Council may wish to contact Thames Valley Police as the enforcing authority to undertake speed checks on the A4010 at Little Kimble to evidence current speeds of traffic.

Supporting information to include the following if a decision is being requested:

Speed Limit:

- Local authorities are required to follow guidance issued by the Department of Transport
 when setting local speed limits. This is to ensure that speed limits across the country
 are consistent and respected by road users. Please see attached link to this guidance

- The speed limit on the A4010 at Kimble was reviewed in 2006 as part of a countywide review of all speed limits. As a result the speed limit was reduced from the national speed limit of 60 mph to 40 mph. During a follow up review in 2009 the 40 mph speed limit was extended further north.
- In the last five years up until 31st February 2016, there has been two slight and one serious injury collisions on the A4010 at Little Kimble within the 40 mph speed limit. Two of these were at the junction with B4009 Grove Lane and involved turning in or out of this junction the other was as the result of a medical episode..
- As a result of the previous reviews and the low collision history the speed limit at Little Kimble does not meet the DfT guidance for a 30 mph speed limit.
- Speed data recorded 145m south of Lower Icknield Way in 2007 indicated that the average speeds of traffic in both directions was 40 mph and the 85th percentile speed (the **speed** at or below which **85**% of all vehicles travel) is 45mph.
- Thames Valley Police as the enforcing authority may wish to undertake speed checks on the A4010 at Little Kimble to evidence current speeds of traffic. The Neighbourhood Police Team can be contacted at http://www.thamesvalley.police.uk/yournh/yournh-tvp-pol-area-n407
- TfB have been aware of this issue since 2014. The site was assessed at that time and there were no immediate defects found which would justify immediate intervention on safety or structural grounds. A Structural survey of one property was undertaken by a resident which concluded:

"Vibration levels have been monitored and assessed in accordance with BS7385 and have been found to be significantly below the levels at which cosmetic damage could possibly occur. The potential for nuisance has been measured in accordance with BS 5228-2 and measurements have been found to be at the level at which vibrations are perceptible and a cause for complaint (0.3 mm.s to 1.0 mm.s).

It has been noted that the road surface outside the property is in poor condition with a large pothole in the road adjacent to the front room. The design manual for roads and bridges lists imperfections in road surfaces as a major contributor to adverse vibration and is likely to be the cause of the vibrations troubling the property."

There is no reason to believe that this report does not still represent he current situation.

- TfB programmed works on areas of sunken utility trenches across A4010. The works were completed and on last inspection remain in good condition.
- TfB Officers have met with the lead petitioner and will continue to ensure that the road
 is inspected on a monthly basis and repairs to local defects continue to be made to
 keep the road safe and to reduce nuisance to residents.
- TfB will consider this petition as part of their prioritisation of road resurfacing schemes, however there remains a significant backlog of maintenance work in the County and so the timing of any future resurfacing cannot be determined.
